There's funding in the amount of \$15million allocated already. The Navajo Nation President need to provide answers where this funding will come from. Ms. Slim is working diligently on projects where the former director left off.
 - Received the Memo dated January 19 that the contract with IDSA was terminated.
 Teesto Chapter is a certified chapter and operates on its own Local Governance. The ARPA funding is Federal money so document everything, keep all records stored for 5-10 years for audit purposes.
 - Law & Order: Will evaluate all judges and do a confirmation on Chief Justice, which was not confirmed. There will be a public hearing.

6. New Business:

a. Approving/Accepting January 2024 Financial Report. Recordino-temp secretary Lucinda Honani read and reviewed the January 2024 Fund balance ledger as presented: Beg Balance \$448,485.02, Expenses \$40,270.62, Deposits \$1,636.07, Ending Balance \$409,850.47. Juanita Lee motioned to accept the budget as presented, seconded by Laura Williams. Motion carried with 15 in favor, 0 - opposed, 1 - abstention.

- b. Requesting and Recommending the Navajo Hopi Land Commission Office to seek, identify and secure \$50 Million to address for 2nd Generation Relocatees Homelessness. Davidson Benton motioned to accept the resolution, seconded by Frieda Thompson. After much discussion on the subject and the extent of its complexity this item was deferred to the next chapter meeting. Many questions were raised on: data for the number of 2nd Generation, 3rd Generation, etc. Also, is there land identified and a proposal? . John Nells recommended a substitute motion to defer this item to the next meeting with more information from the Twin Arrow Relocation Summit meeting hosted by Nahat'ah Dzil chapter. Motion carried: 18 in favor, 0-opposed, 3 abstention.
- c. Approving and Accepting the Emergency Supplemental Fund Budget in the Amount of \$35,000.00. John Nells motioned to approve and accept the Emergency Supplemental Funds in the amount of \$35,000.00. \$10,000.00 to purchase wood & pellets, \$12,013.38 for natural gas & propane, Gas \$6,493.31, Diesel \$6,493.31. Second by Aurora Holmes for discussion. Discussion included: Wood haulers w/permit & registered members Only: Cedar & Pine wood. Price for wood haulers recommended: \$150.00 Short bed, \$175 Long bed. Another recommendation was to consider the high cost of electricity used for heating. This item was deferred back to the chapter officials and administration with recommendations to encourage chapter members to be proactive and be involved by being visible at chapter meetings with an input AND not Only attend a meeting when in financial need. Aurora Holmes exited the meeting therefore, Sharon Begay seconded the motion. Motioned carried with 15 in favor, 0 oppose, 3 abstention.
- d. Opposing Navajo Nation Council Resolution CO-85-23 amending the Local Governance Act to allow Virtual/Hybrid Chapter Meetings and Recommending In-person attendance of all Regular Chapter and Planning Meetings by Registered Voting members of Teesto Chapter. Juanita Lee motions to accept, seconded by Milton Franklin. Pros and Cons were expressed by members including: In-person attendance has more clarity with communication with no technical difficulties which was expressed by most elders. Clara Williams advocated for the resolution stating the young generation needs to be inclusive as they will be the future leaders and to provide media access for their information on chapter issues, etc. Motion carries to approve the resolution to oppose. 15 in favor, 0 - opposed, 3 - abstention.
- e. Requesting, Supporting and Recommending Assistance From the Office of Navajo and Hopi Indian Relocation ((ONHIR) For Homes Built by ONHIR and In Need of Repair. Clara Williams motioned to approve the resolution to ONHIR and seconded by Milton Franklin. Motion carries with a vote of 14 in Favor, 0 Oppose, 3 Abstentions.
