- A. Accepting/Approving 2023 December Financial Report. Chapter Secretary/Treasurer reviewed the 2023 December Financial Report. (Beg. Balance \$479,464.06, Expenses \$33,115.01, Deposits \$2,087.21, Ending Balance \$448,436.26). Motion made John Nells to approve the monthly 2023 December Financial Report, seconded by Aurora Holmes. The vote was 18 in favor, 0 opposed, 3 abstentions. Motion carried.
- B. Recommending terminating technical assistance IDSA and giving direct allocation to Teesto Chapter. Chapter President informed the community members that the agreement with IDSA was terminated, the letter requested was forwarded to Community Development Center(CDC). The recommendation made is to have it on record that the community members were made aware. Homevisits were done and completed. Motion made by John Nells to approve the letter forwarded to CDC for IDSA termination, seconded by Juanita Lee. The vote was 18 in favor, 0 opposed, 2 abstentions. Motion carried.

- C. Recommending a Recognition day for our Sport Athletic Derrick Begay and Danielle Lowman. The invitation to our local athletics for a luncheon to held in their honor, contact the individuals when would be a good time to schedule this event. Motion made by Juanita Lee to approve the luncheon for our local athletics, seconded by Frieda Thompson. The vote was 19 in favor, 0 opposed, 3 abstentions. Motion carried.
- D. Requesting and Recommending the Office of the President and Vice-President, the Division of Community Development including CHID and HIP Programs, Navajo Hopi Land Commission Office, and other programs, Office, and Department to provide New Homes to (6) constituents of Teesto Chapter. The Teesto Chapter conducted its home visits and assessments with IDSA and found six (6) deplorable state of homes or housing beyond repair and are health hazards to the occupants. Some of these families applied for new housing through the Housing Improvement Program (HIP) but were denied while others have applied to Community Housing and Infrastructure Department (CHID) with no feedback as to the status of their applications. There are eight (8) families that need homes. Motion made by Sylvia Largo to approve resolution TEE-JAN-08-2024, seconded by Marie Thompson. The vote was 18 in favor, 0 opposed, 3 abstentions, Motion carried.
- E. Opposing an action relating to Health, Education, Human Services Committee on the 2024-2028 Navajo Nation School Board Apportionment Plan passed on December 4, 2023; and recommending the DBOSBA Apportionment Plan. The Dine Bi Olta School Board Association opposes the 2024-2028 Navajo Nation School Board Apportionment Plan as developed by the Health, Education, and Human Services Committee. The DBOSBA recommends their apportionment plan, which was developed in collaboration and input from school administration, school board members, parents, and other stakeholders. The DBOSBA request that school board members across the Navajo Nation be treated fairly, along with their elected colleagues as they have the same rights to express their opinions and their voices for their local community. The DBOSBA Apportionment Plan (Exhibit A) be approved to be sent out for public comment. Motion made by Aurora Holmes to approve resolution TEE-JAN-09-2024, seconded by Juanita Lee. The vote was 17 in favor, 0 opposed, 1 abstention. Motion carried.
