Teesto was awarded the funding of \$1.7million and out of the fund Teesto will receive \$880,000.00 for housing project and the purchase of the heavy equipment (front-end loader and fork- lift) including \$226,000.00 for labor. Teesto will do their housing project with no warranty and will draft a memo stating that chapter will provide some sort of warranty. Waiting for the Navajo Nation President Buu Nygren signature. All 110 chapters will receive the same amount of funding Non-Certified and Certified. Certified chapters will receive their funding as proposed and use for their project. The five chapters: Whitecone,

Greasewood, Teesto, Dilcon, and Indian Wells, the four chapters will work with IDSA and contractors. Teesto Chapter has decided to work on its own project. The home visits have been completed with IDSA but terminated the contract due to circumstances. Teesto collected 169 applications the proposed number was 300. Teesto is requesting for 3 quotes according to our FMS policy. The funding is coming from the United States Treasury and will be audited. The Chapter Manager has submitted the invoice.

 Requesting and Recommending Navajo Nation Office of the President and Vice-President, Navajo Nation Council, Navajo Hopi Land Commission and NHLC Office to seek, identify and secure \$50 million to address 2nd Generation Relocatee Homelessness. This item was deferred from last month's chapter meeting. Its now has been 50 years since some families have the relocated to various place. Now, the families are seeking housing assistance especially those that have relocated in the 1970's and 1980's who are calling themselves 2nd Generation Relocatees they are seeking some land base for their resettlement that would include water, powerline, roads, and economic development. There are families that relocated off reservation like Bordertown and cities and those denied relocation benefits who resisted relocation who were born and bred on the HPL who now find themselves homeless and without housing. The recommendations to the Navajo Nation Office of the President, Vice-President, NN Council and NHLC to identify and secure \$50 million in funding to address the homelessness for 2nd Generation Relocatees whether it be NN, State, Federal, and other funds. The NN President to take the lead. Motion made by Mona Seamon to delete resolution TEE-FEB-13-2024 and to refurbish the resolution according to the NHLC template, seconded by Lucinda Honani. The vote was 20 in favor, 0 opposed, 6 abstentions.

2. Reaffirming request to Office of Navajo Hopi Indian Relocation to provide repairs to ONHIR constructed relocation homes. It was shared that 814 Teesto community members relocated from Teesto to various area. There were 3 commissioners selected and those members are no longer serving. The Navajo Nation is requesting that a commissioner is selected, the individual who has the authority is the President of the United States Joseph R. Biden. The request is funding from ONHIR for repairs. Motion made by Mona Seamon to approve the request to Office of Navajo Hopi Indian Relocation to provide repairs to ONHIR constructed relocation homes, seconded by Marilyn Ruiz. The vote was 15 in favor, 0 opposed, 3 abstentions.

Requesting that \$50 million of the Navajo Nation's American Rescue Plan Act be repurposed to repair homes and provide hosing assistance to Navajos relocated under Public Law 93-531 and the descendants of those relocates. The supports to Navajo Hopi Land Commission of the Navajo Nation Council to request \$50 million of the Navajo Nation's ARPA be repurposed to provide home repairs and assistance to Navajos who were relocated under P.L.93-531, as well as to their descendants. Motion made by Lucinda Honani to approve Resolution TEE-MAR-15-2024, seconded by Marilyn Ruiz. The vote was 19 in favor, 0 opposed, 5 abstentions.
- 4. Supporting the proposed Northeastern Arizona Indian Water Rights settlement agreement to resolve the Water Rights claims of the Navajo Nation, Hopi Tribe, and San Juan Southern Paiute Tribe to water from the Upper Basin in Arizona, Lower Basin of the Colorado River in Arizona, including the Little Colorado River system and the Gila River system, and recommending to the Navajo Nation Council the approval of the settlement agreement. Motion made by John Nells to approve the Resolution TEE-MAR-16-2024, seconded by Marilyn Ruiz. The vote was 25 in favor, 0 opposed, 4 abstentions.
- 5. Requesting President Joseph R. Biden appoint a commissioner to the Office of the Navajo and Hopi Indian Relocation. The Navajo Nation to request that President Biden exercise his authority under the Relocation Act and immediately appoint a Commissioner to ONHIR that ca be held accountable for carrying out a just and compassionate relocation program. Motion

made by Lucinda Honani to approve Resolution TEE-MAR-17-2024, seconded by Juanita Lee. The vote was 22 in favor, 0 opposed, 1 abstention.
