- 2. Southwest Navajo Tabacco Education Prevention Project (SNTEPP), Hershel Clark. Mr. Pete Nez provided an overview of the organization. The message on the usage and tobacco products that are being sold on the Navajo Nation the idea of increasing sales tax.

 - ARPA-Served 60 families with housing materials and less than 10 have not picked up their check. We are having problems with two (2) vendors, Lowes in Show Low and Home Depot in Gallup with the check that is given to them therefore not recommending working with them. There were visits made to all the vendors and met with Managers. The quotes that were received with the amount is the amount for the check, if the amount is over or less it's the responsibility of the member to either return the money or pay the amount this is for audit purposes. Teesto is waiting on the second disbursement which all the documents were submitted, we are told by the FRF office that there are missing documents, but everything is submitted. Ms. Pauline Thomas will be visiting our chapter to take pictures of the completed project before and after. The advertisement for the contractor RFP was submitted to the newspaper. The bid deadline is May 24, 2024, at noon.

- DEMOLITIIFAN PROJECT-Met with Travis from Arizona Division of Quality. They
 will be doing testing on the old building, they will be testing for mold, asbestos, and
 lead if anyone of these is found they will work on demolishing the building. The
 request is they will need heavy equipment to dispose of the materials.
- DEPARTMENT OF TRANSPORTATION-The roads in the community need improvement/maintenance, restore and widening. Some of the roads have erosion which needs to be maintained. The agreement that is in place with BIA is for flat blading.

The one individual volunteered would like to work as a Poll Clerk. They are concerns shared that the voting machine needs to be updated since at the last election there were problems. The ballots were counted by hand and took longer. Motion made by rose Jensen, seconded by John Nells. The vote was 21 in favor, 0 opposed, 2 abstentions.

- 6. Presentation; Southwest Navajo Tabacco Education Prevention Project (SNTEPP), Hershel Clark & Sierra Wilcox. The overview of Air Is Life and the legislation that was passed by the 21st Council. The information given on E-Cigarettes and Vaping is harmful. The importance of knowing the facts. Increasing Taxes on Commercial Tobacco is important, The benefit of increasing taxes on commercial tobacco products, We need to protect our Dine Youth since there is an increase over the years. The vaping ingredients Diacetyl, Acrolein, Formaldehyde, and Nicotine which are highly addictive and pose severe health risks for our youth. According to the Navajo Youth Risk Behavior Survey its at 40% used e-cigarette products in their lifetime. We need to educate our youth. The legislation on increasing the tax on commercial tobacco that is sponsored by Honorable Council Delegate C. Slater will be introduced at the Summer Session. Our SNTEPP will continue to educate at chapter meetings, events, and schools we need the support with resolutions and such. Motion made by Rose Jensen, seconded by Lucinda Honani. The vote was 15 in favor, 0 opposed, 1 abstention.

 - The proposal of installing a water purification at Teesto Chapter. The importance of drinking purified water is the benefit it has versus the well water. The individuals that are needed to maintain the equipment. The purified water will be used for drinking not livestock.

- 5. WIHCC, Inc. Rep. Johnny Nells.
 - The representation from chapters Jeddito, Whitecone, Indian Wells, Dilcon, Teesto, Birdsprings, and Leupp.
 - Attended the NDOT meeting at Dilcon Community School. We need our roads improved/resurfaced since our ambulances run on these roads and should be a priority.
 - Several months ago, part of the medical center shut down. The information received is that the cylinders
 on the roof top the mechanical part was the problem. The warranty has expired on the parts and costly.
 It's a certain type of commercial parts that needed to be purchased and installed.
 - The Leupp waterline project is still an ongoing project to which two individuals were assigned.
- 6. Seba Dalkai Boarding School, Principal Ms. Bigboy.
- 7. Chapter Manager, Clara Tsosie.
 - ARPA: Very important Project. The chapter received \$1.7 million for home repair and weatherization. It took a lot of planning and meetings. There is a deadline December 30, 2026 to use all the funding and complete the project. Chapter officials and staff are assigned to areas to do their housing assessments. The chapter received its first drawdown in the amount of \$880,234.00 which the two heavy equipment were purchased and sixty of the community members received their checks for their housing materials. The chapter manager delivered letters to vendors that members will be bringing their check for their housing material and turns out that there were problems.

- Contractor BID for advertisement had to be approved/reviewed by DOJ. The process took a long time
 with each department. Navajo Nation's process is so SLOW. There was a meeting with seven
 contractors during the BID opening. What was shared is for bordertown housing repairs it requires a
 permit which needs to be obtained. Several things were shared such as bonding, security, testing for
 bathroom installation and procurement process. The chapter would have to go through the same process
 for advertisement and instead of contractor it would be ON-CALL BID with a deadline July 26, 2024.
- There needs to be a Scope of Work for each of the housing repair.
- There are 62 community members needing service on their homes.
- There will be an unexpected visit from the FRF office to do a home visit if the project is complete.
- Chapter Administration will be closed May 24 due to exterminator being on the compound to spray the buildings including Senior Citizen Center. The staff will be leaving early at 2:00pm.
- The Navajo Hopi COVID Relief accepting application for home improvement/housing material. They are requesting a complete application and documents. The chapter staff can help with uploading your application, documents, and sending them for submission.
- Teesto Website is updated and their resources.

8. Grazing Official, Morgan Yazzie.

- Expressed appreciation for the help with housing material. The effort that was put into place and planning it took. We need to show our respect and appreciation.
- The travels that Grazing Official do come out of our own pocket. The responsibilities that come with being a Grazing Official.
- We need to understand and listen to one another. Let the person finish speaking and don't interrupt.
- The meeting that took place in Gallup during the Critical Path marked a change in the Department of Agriculture. The reissuance of livestock permits on the NPL and heirship what's the status was asked by Director with Natural Resources, the response was BIA not Navajo Nation. Therefore, individuals were let go. RDC has not attended any of these meetings.
- Attended all the monthly meetings and work sessions.
- Let's spend everything and get your family to help with labor. The need of certified workers is not needed, let's hire our own local carpenters.
- There was eclipse and recently the Northern Lights came upon us, how many prayed and were blessings done? We need to practice our belief and prayers, lets continue to teach to our children and relatives.

1. President, Elmer Clark,

- The idea given on the water purification system and water dispenser.
- Teesto Development Corporation is a Non-Profit Organization and need a Grant Writer to seek funding. We are requesting funding and support letters were sent out to City of Winslow Mayor requesting for \$10,000.00 and Walmart for \$20,000.00 with these funds we could plan for farming supplies such as irrigation system and other futures ideas/plans.
- Announced for the upcoming Navajo Election, re-elect for Chapter President, Vice-President, Secretary/Treasurer, and Grazing Official,
- The roads need to be graded and maintained.
- Home visit to D. Nells, the house is beyond repair.
- June 12, 2024, scheduled for Family Fun Night. We need to bring our community together for a fun evening, cook-out, play games, and outreach.
- The GYM is open Thursday and Friday from 9am 4:30pm.
- July 17, 2024, scheduled for Community Education Development Day. The plans for a community cemetery and future housing.
- There is a recall initiative taking place with the Council Delegate C. Yazzie. She has not attended our chapter meetings monthly and in need of her help which is lacking. We need her help with sponsoring legislation. Where is she??
- The water treatment plant that is in discussion, we need our council delegate to help with legislation along with RDC.
- Navajo Hopi Land Commission, Otto Tso is still planning on conducting their meeting here at our chapter.
