# V. REPORT/PRESENTERS:

- 1. WIHCC, Inc./DMC: Virgil Davis, CEO.
  - Currently doing Strategic Planning.
  - Provided updates on the current event with Trump Administration. The funding that is received from the Federal Government is what the impact would be. This funding will affect all 638 hospitals, BIE/BIA, and other programs. President Trump has sign Executive Orders since he took office and still signing Executive Orders. The impact on P.L. 93-638 Legislative 14112 affects healthcare. There will be a big cut in Medicaid ACCHS around \$880 billion and it will affect our healthcare, if you are able to work must work. So far, our hospital/clinics haven't

been impacted yet. As for employment, positions are open and still hire if qualified. The Treaty of 1868 states that the government will provide Education and Healthcare they are obligated.

- 2. NHA, Audrey Gishie, Intake Specialist.
  - Provided an overview of Navajo Housing Authority history, how funding is received from the two programs (Funding 1 1937 Act and Funding 2 NAHSDA) and the qualifications of housing public rental and homeownership. The homeownership's responsibility once the home is paid off. NHA works with other programs for scattered housing. NHA must comply with regulations. Most of the housing in Teesto is paid off and NHA no longer will assist with any funding and it's the responsibility of the homeownership maintenance or home improvements. There was an organization in Teesto which can be re-established.
- 3. ASC, Toni Mina, ASO.
  - Provided an overview of the monthly financial reporting. The monthly financial check off list for chapter official review monitoring tool. The submission of monthly reporting to ASC. The review of Statement of Revenue and Expenditure, Balance Sheet, and Budget Actual Summary.
- 4. Navajo County Board of Supervisors, Alberto Peshlakai.
  - Update of the most recent passed Resolution on the Gravel Project and waiting on a couple chapters to pass their resolution. Once all Resolution are passed and will start working on securing funds in the amount of \$6.9 million.

  - The newly elected officials are mostly Republican and need to introduce themselves to residents.
  - Navajo County aid chapters when they need help.
  - I-40 road closure during winter conditions or accidents. Motorists find ways to avoid road closure by using their GPS on their cellphone. All motorists must stay on main roads and not other roads such as gravel or dirt roads where they might get stuck. Some of the roads are not made for oversize loads, law enforcement are notified to stop all traffic.
