Requesting to NHA to continue to provide technical assistant to Teesto Chapter for plan for additional housing units that was put on hold in FY 2022 due to inadequate water and electrical resources. Teesto chapter and NHA initiated planning activities in FY 2021 for additional housing units in the community by the increase request of more housing assistance. In 2022 NTUA released the electrical and water utility capacity analysis reports did not have the electrical and water infrastructure for the housing units. This put the project on hold until such time. There is now a 3-phase line (electrical) and waiting the release of the water from Leupp. TPZC is working on these proposed plans including a C-Store at the crossroad Teesto Assembly of God and Hwy 87.

The agreement is to authorize the chapter to assist the Bureau in the performance of road maintenance activities on earth and gravel roads specifically BIA routes which are within the boundaries of the chapter.

Motion: Johnny Nells approved Resolution TEE-NOV-08-2026. Teesto Chapter has employed a local heavy equipment operator through the Public Employment Program within the past year. He can operate the grader, front end loader, and fork lift. Heavy Equipment Operator provides hauling water and grades the roads when needed, also performs general maintenance services for the facilities/building with the Teesto Chapter tract. The HEO position deserves health benefits, annual/sick leaves, and pension.
